The e-voting period will commence at 10.00 a.m. on 27<sup>th</sup>December, 2015 upto 5.00 p.m. on 29<sup>th</sup> December, 2015. During this period, Members may cast their vote electronically. The e-voting module shall be disabled by CDSL thereafter.

The voting rights of Members shall be in proportion to the equity shares held by them in the paid up equity share capital of the Company as on 22<sup>nd</sup>December, 2015 ('cut-off date'). Any person, who is a members of the Company as on cut-off date is eligible to cast vote on all the resolutions set forth in the Notice of AGM using remote e-voting or voting at the AGM.

The facility for voting, either through electronic voting system or ballot or polling paper shall also be made available at the AGM and Members who have not already cast their vote by remote e-voting shall be able to exercise their right at the AGM. The Members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again.

A person who has acquired shares and becomes a members of the Company after the dispatch of notice of the AGM and holding shares as of the cut-off date , may obtain the login ID and password by sending a request to helpdesk.evoting@cdslindia.com . However, if the person is already registered with CDSL for remote e-voting then the existing user ID and password can be used for casting vote.
