Such programmes will be conducted for new and continuing Independent Directors of the Company.

- Regular updates

Independent Directors shall be provided with updates during various Board/Committee meetings on Industry developments and regulatory updates, as necessary and update on statutory compliances for Board members including their roles, rights & responsibilities.

- External Training Programs

Independent Directors may also be offered options to attend training programs like seminars, conferences, workshops, etc., conducted by external agencies, relating to the industry/statutory and regulatory provisions.

3. Programs and Disclosure

This familiarization program shall be conducted from time to time and/or as and when need arises.

This Familiarization Program shall be uploaded on the Company's website and a web link for the same shall also be provided in the Annual Report of the Company.

4. <u>Revision or modifications to the program</u>

Any revision or modification to this program shall be made by the Board of Directors from time to time.
